A. COMMITMENT - MANAGEMENT OF SOUNDSCAPE COMPLAINTS

As part of the Action Plan, ADM has prepared a commitment on the management of soundscape complaints. The commitment was presented to Committee members, was modified as per their suggestions and was adopted at this meeting. The Commitment will be posted on ADM's website.

B. INDICATORS - MAY TO AUGUST 2019

A new aircraft movement indicator at YUL is presented to the Committee members. This indicator has been available on ADM's website for the last few months.

It is an interactive platform of operational indicators for the past 12 months. The user can choose a particular month or the period of the last 12 months. The statistics on the use of the runways are part of this indicator.

A table of indicators on complaints is also presented. This is an interactive platform with statistics according to the day, areas, cause of disturbance, and the number of complaints submitted by the 10 most active complainants. These indicators will be available on ADM's website as of January 2020.

C. CONSTRUCTION WORK 2020

The work for the rehabilitation of runway 06L-24R will continue in 2020.

In 2019, runway 06L-24R was operational with reduced length (displaced threshold) from March 18 to June 20 and from September 3 until December.

• Impact: large aircraft assigned to runway 06R-24L (south Dorval, south St-Laurent, Town of Mount-Royal, Villeray-St-Michel-Parc-Extension)

More information on the work scheduled for 2020 will be presented at the December meeting.



D. SOUNDSCAPE ACTION PLAN

The action plan features eight categories:

- Complaints management
- Nighttime operations
- Quieter Fleet
- Noise mitigation procedures
- Preferential runways
- Noise measurement and reports
- Land use
- Community

The priority actions for 2019 are:

Consult the boroughs and cities located under the paths of the runways about the action plan.

The purpose of the meetings was to provide general information on the soundscape, present the action plan and priority actions, and to gather input and concerns from elected officials.
