

## New function – App for cell phone

- New function a « Submit Now » button for complaints filed using a cell phone – one click to send a complaint
- Newsletter sent to announce this new function
- Email sent to everyone who filed complaints using AEROplainte that were not registered
- 6,019 complaints filed with AEROplainte from May to August were not transferred by its developer
- Several exchanges with the developer for the transfer of complaints – the last complaints were transferred on April 27, 2021







Note: In April and May 2020, there were 816 and 670 complaints filed by e-mail that are not included in the total number of complaints. They are included in this table to show the level of disturbance despite the decrease of air movements.





## Indicators – May to August 2021 Complaints linked to YUL

- 3,230 complaints / 93 complainants
- 83% of the complaints were filed by 5 people
- 4% of the complaints are linked to a movement between midnight and 7 a.m.





#### Distribution of complaints by runway:

Runway	Arrivals	Departures
North runway Northeasterly winds (06L)	0.2%	7.3%
South runway Northeasterly winds (06R)	7.0%	10.1%
South runway Southwesterly winds (24L)	9.3%	50.6%
North runway Southwesterly winds (24R)	13.8%	1.7%



# North Runway Rehabilitation Work

- ADM is planning to do the rehabilitation work on the central section of the runway in two phases: the first in the spring of 2022 and the second in the spring of 2023 (spring = mid-March to end of June)
- This will require the runway to be closed during the work.
- Request to Transport Canada for the required amounts through the Airports Critical Infrastructure Program – awaiting a response.





## Soundscape Action Plan

The priorities of the action plan were reviewed in 2021, taking into account the results of the consultation held in 2020 and the constraints related to human and financial resources in the context of the pandemic.
